## **Summary**

The research role of the League of Arab States in Iraq's political after 2003 and the relationship between them, especially after the change experienced by the Iraqi political system (the regime of Saddam Hussein) and the occurrence of Iraq under the U.S. occupation, and created by change and occupation of the results and repercussions impacted heavily on the type of relationship between University Arab countries, Iraq and reflected the attitudes and reactions.

The research was divided into four chapters and eight Investigation and sixteen requirement, where each chapter contains two sections Oml Study of the central demands.

The first chapter, entitled "the Arab League and Iraq from incorporation until 2003", and devoted first section of this chapter for the establishment of the university and its formations, where he addressed the first demand from the establishment of the Arab League, eat second requirement most important formations League of Arab States.

The second part, titled "The position of Arab League Vqdtk national reconciliation and terrorism in Iraq," where Bmtlpin came the first of which dealt with the position of the League of Arab States of national reconciliation, addressing the second requirement the position of the League of Arab States of terrorism in Iraq.

Finally came the fourth quarter of this research entitled "The Future of the relationship between Iraq and the Arab League after 2003" This chapter was Bembgesan first one titled reality Iraqi-Arab relations and the future, and this was Section Bmtlpin eating the first of them the reality of Arab relations Iraqi (Kuwait, Syria, Egypt ) a model after 2003, addressing the second requirement future of relations between Iraq and Arab countries after 2003, and came second section of Chapter IV entitled "The Reality of diplomatic relations between the Arab League and Iraq and its future after 2003", and this was Section Bmtlpin eating the first two track diplomat, eat second requirement future of relations between the Arab League and Iraq after 2003.

Then came the conclusion to summarize or the findings of the search results, where Iraq has become today has the potential self-qualify
