The disintegration of the last soviet Union, besides to the cold war have led to a beginning action of a new stage of international evolution system stage which is surely unpopularity and thus, it endeavored to dominate and control all the world ant to intervene in their internal affairs in order to protect the interests affairs in order to protect the interests of ether the security, commercial or economic, especially in the middle east region, due to the oil on the hand on the other hand, the existence of Israel. The idea of the power and the principle of military superiority have dominated American forging policy. Power doesn't mean the military one only, but it means all its kind's (smart, soft, solid) which means all American powers standers that involved information, technological, scientific, educational, economic and military power, more to the other devices which are involved by the US administration to protect and implement its international affairs. So, the power is considerable as basic foundation which is totally reliable by in the US administration to implement and fulfill its interest in the international system. There wasn't any role for the US in Iraq before the World War II. It was dedicated intensively to ensure its oil economic interests in cooperation with Britain through recognition of control over Iraq.

American forging policy attitude towered Iraq wasn't out of the basic standers for strategic interests con careened with economic resources and after a conflict with the major power dominated the Middle East represented by (Britain, France and Netherland). It got oil (Britain, France and Netherland). It got oil concessions at that time for the purpose of exploration and investment so the US has consilo dated its influence in Iraq after the end of the World War II. The US has tried to use Iraq as a shield to counter the threat of the communist tide of the Arab region and that was by using (alliance policy) including. The Baghdad pact.

The United States of America used Iraq after the establishment of the Iranian Islamic Republic as an alternative face Iranian danger and declared the war instead, by supporting Iraq government with intelligence and military plus, but after the end of Iraqi_ Iranian war, USA figured out that Iraq had a major Military arsenal rather then to destroy the Islamic administrations. That made the vomited states kept seeking to the Iraqi government in the invention of Kuwait and the then it was freed by the international coalition and the Iraqi power and ability to change the Iraqi regime by destroying the previous one and that was after the end of the cold war. And it was done after the events of the 11th of Sep. 2003.

The United States used military hard power several times in Iraq, besides using various weapons and even banned ones. It also used soft and smart power through issuance of the economic embargo resection of the UN Security Council and that it was in order to destroy the Iraq military power and establish a new Iraqi government so as to ensure that will never be an Iraqi government may pose a threat to Israel in the future.
