## summry

The research stood up ( the traveling and transporting liberty) on the theory including that the stats obligation to respect the general rights and liberties with the specific right that is the travel freedom, and transporting dosen, tadmeasuring merely is including the laws and constitutions of those Stats on the fourth right provitions which indicated on the conciding with what is written in the international documents and promises with this right, but with that effect on these obligating ( negative and positive) in the possibility range to go by specific authorities in misusing authorities empowered according to law, for the regulate exercising this right, or for keeping order of the puplic system in the moral, health and security way.

Over and above of that what are availability and efficiency of the. judicial control on the constitution of laws and order which it accordance and wroughth in administrating the liberties and rights affairs, specially with rights of travel an transporting, as we judicial control on the administration works, specially with that take from dedcisions in the single volition in affairs of the puplic liberties and rights (as the rigfhts of travel and transporting) if it those decisions were individuality or regulatory.

Our research proved through applying it,s subjects on the rights of travel and transporting in Iraq in past and at present the truth what was proceeding in this theory whence absence of the constitutional and judical warranties in the past, which lead up to broad abuses for this right, whereas become unlikelihood, getting like thos abuses in new Iraq because having truth guarantees, its what was conduct us to proffering some recommendations which may discribing as the good exploitation to nature of the new political and constitutional system to get high using in the drafting scope of rights and liberties, one of those is right of travel and transporting with its different details.

Significance of research is to statement effecting of the travel and transporting right on another personal, civil, political and economical

rights, if its was not transgressed, and available for it the enough security to face puplic authorities, specifically executive authority and its administrative system, because it effecting on the political rights, where as requiring its exercising without put bounds and transporting of citizens and prohipit them from that, also not allowing seizure or jailing for anyone without legal proof, that denying from travel and transport, rigfht that meaning disqualify from exercising the political rights as right of electiong right ( electors of erecters ) to prohibiting them from go for the elective station, if that was jailing or prohipit made from traveling, also its effecting on economical, commerce, industry, workers and capital transporting rights inside or outside state and among states, and also possession right. So, whole those rights are nothing when the individual cannot moved to exercising the mentioned liberties and rights as well as reference to effecting those rights to the personal rights, specially the rights of safe feeling with regard what is basis of the travel right
